APPENDIX Q WORSHIP, LEARNING AND MEMBERSHIP Report for Nov 2021

We have come a long way since our last report on Sept 29.

IN PERSON WORSHIP—Now having full worship, with congregation masked at all times and double vaccinated. Each congregant sanitizes upon entry and has vaccination card scanned by greeter, then encouraged to sit wherever they are comfortable. No requirements for social distancing at the moment. Speakers and singers still remain behind plexiglass barrier when unmasked.

Numbers for in person attendance continue to rise with about 35 a few weeks back. Zoom is still offered most weeks, with anywhere from 5 -10 people joining in this way.

MUSIC - Alexis has worked out a great schedule of guest pianists. These individuals sharing of their talents is so appreciated and an unexpected gift to all present each Sunday. Mary Dalton continues to contact people to offer special music and thankfully, Jim continues to be our voice until we can all join in song. There is a lot of humming and singing in behind masks as the music moves us.

SUNDAY SCHOOL - Stacey Wilson and Kathy worked to create a program for all the children based on rocks. Using scripture stories about rocks, strength, support and love, packages were created for children to receive rocks to be painted. These were to remember they are strong; they are loved, and they are never alone. They have been given a name and contact information if they would like to make a rock for someone in the congregation. Kathy has been sharing a weekly YouTube video about some other connection with rocks, one which included our singing office administrator.

Mary, Colleen and Kathy have met a couple of times with some of the older children. This has always been outdoors. Once to gather rocks and then to create Inukshuks with about 8 of these kids. They talked about rocks, strategized, and laughed as they created the Inukshuks in front of the church. They were absolutely thrilled to be together and "at church". It was wonderful to see their joy.

We will see what restrictions hold but the hope is to have another meaningful gathering outdoors during the advent season.

Plans are being made to keep connections for the children but not in the building yet. We will continue to visit this question as time and Covid situation carries on.

WORSHIP SERVICES - Communion in October worked well with each attendee bringing their own bread and drink. There was also some of these elements safely prepared for individuals who may have forgotten.

Thanksgiving service was enhanced with beautiful gifts of produce brought and arranged by Gaileen Kingdon. Baptism of Bennett and Hanna Brown took place before the Thanksgiving service.

Oct. 17 saw Julie, Carol, and Colleen leading worship. All three of us enjoyed the morning and working together.

It was great to see Legion members attend the Remembrance Sunday Service.

Worship during Advent - is still in the planning stages. The worship committee meets tomorrow, and Kathy has a study/ planning week to find direction for the season. We will let you know dates and plans as soon as that is set. Assuming a Christmas letter will be going out to the congregation and these plans, dates and times can be included in that.

BELL CHOIR - Are practising on (most) Wednesdays. They hope to take part in the service on Dec. 12th.

CLEAN UP - Stacey Wilson, Kathy, Betty Iverson and Colleen spent time cleaning and sorting Sunday School and Worship materials in the storage Room and choir room. It was a great opportunity, to be able to see what is available for decoration, for special services and for Sunday School and to find out just where everything is.
